- according to the national statutory provisions of the individual European countries, and those of Turkey, Cyprus and the countries bordering the Mediterranean relating to the international or cross-border road transport of goods by motor vehicles;
- according to German statutory provisions, in particular Secs. 407 et seq. HGB (German Commercial Code);
- further liability under the contract of carriage agreed with the customers, within the framework of the stipulated statutory liability range in accordance with Sec. 449, Sub-Sec. 2, Clause 1 HGB with respect to up to 40 special drawing rights per kilogram of the gross shipment weight;
- according to the Convention on the Contract for the International Carriage of Goods by Road (CMR);
- The coverage meets the minimum requirements of Sec. 7 a of the German Haulage Act [GüKG].

For each claim the Insurer's indemnity for freight losses and freight consequential losses shall be limited to EUR 1.000.000. The insurance limit per each loss event is EUR 2.500.000.
